**APPLICATION NUMBER:** 17/00308/FULL  
**ADDRESS:** 21 Cooper Road, Ashurst, Southampton, SO40 7DB  
**PROPOSAL:** First Floor extension; single storey extension; dormer windows  
**CASE OFFICER:** Liz Young

We recommend REFUSAL, for the reasons listed below, but would accept the decision reached by the National Park Authority's Officers under their delegated powers.

Despite changes to the original plans, the committee still felt that the roof mass was too bulky, and that it was an overdevelopment with the confines of the plot. It was also noted that the single storey extension now appeared to be closer to the boundary which the committee felt was unacceptable.

The committee felt that the proposals were in keeping with the property and surrounding area and were within the Village Design Statement, and were an improvement on the existing conservatory. Some concerns were expressed regarding the height of the fence at 1.8 metres.

The committee noted that they found the construction statement a useful and informative document and that it was good practice to provide one.

The committee found no issues with the proposals. The design and materials were in keeping with the existing and the area.

The committee heard from the applicants who gave a brief precis of their plans.

We recommend PERMISSION, for the reasons listed below, but would accept the decision reached by the National Park Authority's Officers under their delegated powers.

The committee noted that the extension was in keeping with the property and with the area, noting that other properties of that design had similar extensions. Concern was noted that, although the property did not come under the small dwellings floorspace limits, it would represent a considerable enlargement of a small property. The committee were keen to ensure that the soakaway was of a sufficient size as the rear garden areas on the properties in Wharton's Lane are subject to flooding. Also that the tree roots should be properly protected from the development.
