**NOTICE IS HEREBY GIVEN** that New Forest District Council, acting as agent to the traffic authority, Hampshire County Council, proposes to make an Order to allow carriageway/footway and drainage works to be carried out, as follows:

## **ROADS TO BE CLOSED:**

#### **Boldre**

B3054 Beaulieu Road between its junction with C75 AT Bull Hill and a point 700m southwest of that junction. Carriageway resurfacing- 15 days 0700hrs-1900hrs.Alt route via B3055, Mill Lane Brockenhurst, A337, A35.

### **Bramshaw**

B3078 Roger Penny Way between its junction with B3079 at Brook and its junction with Long Cross. Carriageway resurfacing 15 nights 2000hrs-0600hrs.Alt route via A338, A31 B3079

Forest Road between its junction with Roger Penny Way and its junction with Woodside Bottom Road. Carriageway resurfacing 15 days 0700hrs-1900hrs. Alt route via B3079 and B3078 Roger Penny Way.

#### **Brockenhurst**

Balmer Lawn Road between its junction with A337 Lyndhurst Road and its junction with B3055 Mill Lane. Drainage works at Rail Bridge. 30 days 0700hrs-1900hrs. Alt route via A337 and Mill Lane.

### Burley

Holmsley Passage between its junction with A35 Lyndhurst Road and its junction with C10 Station Road. Carriageway resurfacing 15 days 0700hrs-1900hrs. Alt route via A35 and C10 Station Road.

# Denny Lodge

Beaulieu Road between its junction with C97 Yew Tree Heath Road and its junction with B3056 Lyndhurst Road. Carriageway resurfacing 15 days 0700hrs -1900hrs. Alt route via North Ln , Hatchet Lane, Palace Lane, Beaulieu Rd, A326 Hythe Bypass.

C97 Dibden Bottom Road between its junction with A326 and its junction with C63 Beaulieu Road. Carriageway resurfacing 15 days 0700hrs-1900hrs. Alt route via Beaulieu Rd, Twiggs Lane and A326

# Fordingbridge

A338 Salisbury Road between a point 90 north of its junction with Redbrook Farm track and a point 35m south of its junction with Bicton Lane. Carriageway resurfacing 5 nights 2000hrs-0600hrs.Alt route via B3078, A31, A338.

#### Hordle

C430 Silver Street between its junction with Vaggs Lane and its junction with Woodcock Lane. Drainage works 20 days 0700hrs-1900hrs. Alt route via C430 Ashley Road/Lane, B3058, A337, C430 Sway Road.

# Hythe and Dibden

Butts Ash Gardens between its junction with with Butts Ash Lane and the end of the cul de sac. Drainage works 25 days 0700hrs to 1900 hrs. No alt route available.

Butts Ash Lane between its junction with Forest Front and its junction with Forest Side. Drainage works 25 days 0700hrs-1900hrs. Alt route via Roman Rd, Beaulieu Rd, Butts Bridge Hill, Fawley Rd.

Ladycross Road between its junction with Roseberry Avenue and a point 250m southwest of that junction. Carriageway resurfacing 60 days. 0700hrs-1900hrs. Alt route via Ipley Way and Deerleap Way

# Lymington and Pennington

Bath Road between its junction with Solent Avenue and its junction with Nelson Place. Drainage works 30 days 0700hrs-1900hrs. Alt route via Solent Avenue, Queen Katherine Road, Nelson Place.

C430 Sway Road between its junction with Mount Pleasant Lane and its junction with Ramley Road. Carriageway resurfacing 15 days 0700hrs-1900hrs. Alt route via Ramley Road and A337

## Lyndhurst

A35 Bournemouth Road between its junction with Shrubbs Hill Road and its junction with Pinkney Lane, Bank. Carriageway resurfacing 15 nights 2000hrs-0600hrs. Alt route via A35, A337 B3054, A326.

### **New Milton**

Albany Close between its junction with Barton Court Avenue and the end of the cul de sac. Footway resurfacing. Intermittent closures, max.30 days. No alternative route available.

B3058 Fernhill Lane/Bashley Road at roundabout. Carriageway resurfacing at roundabout. 25 nights 2000hrs-0600hrs. Alt routes as signed on site.

# Ringwood

B3347 Christchurch Road between its junction with Parkside and its junction with Stag Business Park. Drainage works 15 nights 2000hrs-0600hrs. Alt route via A31, A338, B3073, Christchurch Bypass, Stony Lane.

## Totton and Eling

Downs Park Avenue between its junction with Eling lane and the end of the cul de sac. No alternative route available. Footway resurfacing 60 days.

Westfield Road between its junction with Mayfield Avenue and its junction with Water Lane. Footway resurfacing 50 days 0700hrs-1900hrs. Alt route via Mayfield Ave, A36 Salisbury Rd, Water Lane.

Mayfield Avenue between its junction with A36 Salisbury Road and its junction with Sunset Road. Footway resurfacing 60 days. Alt route via Sunset Road, Water Lane, A36 Salisbury Rd.

PERIOD OF CLOSURE: From 4<sup>th</sup> April 2016 for a period of 12 months or until completion of the works whichever is sooner. (Notwithstanding the above it is expected that each closure will required for no longer than as indicated above.) With the exception of any emergency works, all closures will be notified a minimum of 2 weeks in advance and diversion routes will be signed at the time of closure. Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
