### Mike Craig;

Raised the matter of flooding between the junction of Fletchwood Lane and Busketts enclosure. Water was causing danger to motorists and affecting nearby houses.

PC; Agreed to contact the Forestry Commission to request that they clear the ditches.

### David White;

Updated the PC on the speed limit on Woodlands Road. He thanked Cllr Thomas for attending the demonstration.

Mr White had received a reply from Cllr Sean Woodward who apologised for the delay in replying but still did not address the main issue. Mr White gave a copy of the letter for circulation amongst councillors.

An article from the Lymington Times in 1941 was shared; a letter requesting the reduction to 30mph of the speed limit on Woodlands Road!

## Ian Oliver;

Reported that it was unlikely that the children's allotment competition would go ahead as there was only one entrant. Also that the ground at the allotments was improving.

### **Alistair Hutchin:**

Queried when the central area outside the precinct of shops was going to be tidied up as it was mentioned a number of months ago. Amended; Also that there are two rotten posts in the precinct that need attention. Cllr Coaker answered that the clerk is currently investigating who the lands belongs to.

# Jonathan Bull;

Raised the issue of damaged verges and residents concern that it may affect property prices. Residents are making efforts to repair the verges themselves but could do with the support of the PC.

Dragon's teeth were suggested as a solution.

Cllr Lacey enquired whether there were key places where the damage was especially obvious.

Cllr Coaker reminded everyone of the reasons of cost and risk why HCC were reluctant to take any action.

It was agreed that the PC will contact highways again about the issue.

## **Heather Richards**;

Raised concerns about a local plan and wanted to raise awareness amongst councillors.
