PD021/047 Village Design Statement – recap and next steps

Our VDs was produced in 2013 and things have changed since then. The VDS was last discussed in March 2021, and it was agreed that Councillors would be responsible for different zones of the Village and gather pictures and evidence in preparation for an updated VDS. Councillor Robinson recapped on the last position as everything had stopped because of Covid, things being lost in translation over Zoom meetings, and the resignation of the previous Parish Clerk. The New Forest National Park Authority wrote in 2019 to suggest updates to the 2013 VDS and reflect changes in Park Policy. Councillor Robinson suggested that members formed an informal Working Party to get together and discuss a possible rewrite of the VDS, checking neighbouring parishes VDS to see how they have reflected the recent NFNPA changes. All members of the Planning Committee expressed interest in forming the Working Party and it was agreed to invite Cllr's Smith and Torkington who would be present at the Full Council Meeting to join them as well.
