Cllr Robinson – Following the NFNPA Planning Meeting where the Whartons Lane application had been given permission despite our concerns about safety, Steve Avery at NFNPA had replied to Cllr Robinson stating that the NFNPA were confident that Condition 15 had been met and that there was no expectation that the Parish Council would have to take on responsibility for the 'green area' in the plans. - **3)** Contact a Planning Solicitor to find out costings for a Judicial Review; what this entailed, costings and if this was a feasible option for the Parish Council and its limited funds.
